A COMPENSATION STUDY IS PERFORMED ANNUALLY BY THE BOARD CHAIR AND PRESENTED TO THE FULL BOARD. RESULTS OF THE STUDY ARE DOCUMENTED AND MAINTAINED IN A CONFIDENTIAL FILE.
