






MEMBERSHIP FY 2021-2022

Science and Climate

The Adirondack Council, after leading efforts to address acid rain, is now spearheading advocacy for federal and state actions to combat climate change impacts in the Adirondacks, and secure critical Park science, research and monitoring investments. Federal infrastructure and climate actions have been historic. New York is leading with legislation, funding and a draft climate action plan. Earlier this year the Environmental Protection Agency (EPA), with a budget reduced by the previous administration, closed multiple air monitoring stations in the Park. A Council lead coalition helped Senator Schumer secure funding so they could reopen. The Council also led a coalition that secured \$500,000 to jump start a three-year \$6 million dollar Survey of Climate and Adirondack Lake Ecosystems (SCALE).

Wilderness, Overuse and Equitable Access

For over five years New York State and key partners studied the overuse problem, tested ideas and finalized a report written with assistance from the Council. This year, the State expanded funding to \$8.6 million and implemented more recommendations to address wilderness overuse, education, stewards, sustainable trails, improved trailheads and access, a small pilot permit system and funds dedicated for third party visitor use management expertise. The Council also secured State action to start a new Forest Ranger academy and the hiring of more assistant forest rangers, in addition to increased funding for the Adirondack Diversity Initiative and Visitor Interpretive Centers in Newcomb and Paul Smiths.

Jobs and Broadband


In response to community requests, the Council helped secure over \$1 billion in funding for and expanded availability of broadband and helped eliminate the utility fee barrier to last-mile connections, to expand connectivity and support park jobs. The Council's Forever Adirondacks Campaign successfully advocated for a new \$2.1 million Timbuctoo Climate and Careers Institute for City University of New York students and others with the SUNY College of Environmental Science and Forestry in Newcomb. The Institute will be a new jobs pipeline and foster more diverse vibrant Park communities.



VISION 2050 - Fulfilling the Promise of the Adirondack Park

The Adirondack Council released the publication Adirondack VISION 2050, a long-range vision for the Park. The report was informed by three years of input from over 100 local, regional and national stakeholders and scientists. It responds to threats and opportunities with 250 recommendations to preserve ecology, sustain communities and improve park management.



OPERATING EXPENSES





The Adirondack Council advocated for a Clean Water, Clean Air and Green Jobs Bond Act. Governor Hochul and the Legislature approved a \$4.2 Billion proposal for capital projects that curb greenhouse gasses and combat climate change. Wilderness protection, green energy, and energy conservation benefit the Park's ecology, economy and public health. The Bond Act goes to New York voters in November.

Over the course of five years, the NYS Clean Water State Revolving Fund, which the Adirondack Council helped secure creation of, has awarded \$88 million to Park communities to keep pollution out of Adirondack waters. 

IN MEMORIAM

Timothy Lincoln Barnett (1940-2022)

Tim Barnett was a nature-lover working for a television advertising department in the New York metro area during the 1970s. Because of family ties to Camp Dudley, Tim settled in Westport and eagerly accepted a job establishing what would become the Adirondack Chapter of The Nature Conservancy. By 1975, Tim was recognized as a conservation leader and was asked to join the board of a new advocacy organization called the Adirondack Council. The first meetings of the Council board of directors were comprised of representatives of organizations as large as the Sierra Club and Natural Resources Defense Council, and as small as the Hawkeye Conservationists, of Silver Lake, in Clinton County.

As the two organizations grew, they shared office space on Church Street (now Hand Avenue) in Elizabethtown. By the mid-1990s, both organizations had outgrown that space. Tim built a new building for his staff in Keene, while the Council expanded its office footprint and opened a new office in Albany. That allowed the two organizations to remain close enough to communicate regularly, but not get into one another's way. The Conservancy

could avoid the controversies of pressing hard for political action, which might upset private landowners and forestall protection agreements. The Council was free to seek political change without interfering with important land purchases.

Best of all, Tim's long career allowed him to be an advisor and mentor to two generations of environmental leaders, both in the land trust and advocacy fields. His intelligence, kindness, sense of humor and unwavering commitment to the Adirondacks will not be forgotten.

There is just one hope of repulsing the tyrannical ambition of civilization to conquer every niche on the whole earth. That hope is the organization of spirited people who will fight for the freedom of the wilderness.
